The ICE requirements are that you have any UK bachelor's degree or equivalent or an approved level 3 qualification. It doesn't have to be accredited. Young Professional Members shall transfer to the grade of Ordinary Member upon attaining MICE status or at the age of 35, whichever is the sooner.

**If applying for Young Professional Membership, you MUST include:**

- Evidence of any UK bachelor's degree or equivalent or an approved level 3 qualification **if you are not already GMICE.**

**If applying for Ordinary Membership:** You can join us at this grade if you have been admitted as a Member or Fellow of the ICE (MICE or FICE), or have met equivalent requirements. MICE requirements are any UK bachelors degree or equivalent.

**If applying for Ordinary Membership, you MUST include:**

## **METHODS OF PAYMENT**

Payment is due no later than 1st January, and can be by one of the following methods:

- (a) **By Direct Debit** from a U.K registered Bank account only. **Please note that the preferred method of payment is by Direct Debit.**
- (b) **By Credit Card** (only MasterCard/Visa/Switch)
- (c) **By Sterling Cheque** or bankers draft. These must be for the total amount in £ sterling and drawn from a U.K bank account.

### **Payment by Direct Debit**

New Direct Debits must be completed and returned with your application to: The Membership Registry Department (address on direct debit form below) by 31 December for the payment to be collected in January of the following year. If you are setting up a Direct Debit after 31 July and before 1 October, this will not be taken until January of the following subscription year so please contact the subscriptions team when they email you your membership number to make a payment for your current year's membership fee over the phone.

If the completed direct debit mandate is returned after 1 January, payment (*only for this initial subscription*) should be made by cheque or credit card, and the direct debit details will then be set up for the following year.

#### **Use, transfer and storage of personal data**

We may hold any of the following items of personal information about you:
